Notice is hereby given that on Tuesday, July 12, 2011, the County Council of Prince George's County, Maryland, will hold the following public hearing:

The Prince George's County Council adopted CB-37-2009 (DR-2), pursuant to State law, to authorize the use of Speed Camera Monitoring Systems to regulate traffic in the County. Pursuant to Section 3 of CB-37-2009 (DR-2), the County Council shall hold at least one (1) public hearing to obtain public comment on potential locations for the installation of speed monitoring systems prior to their installation.

The Prince George's County Department of Public Works & Transportation and Police Department have developed a list of potential locations that have been identified as "Established School Zone Sites" as required by Section 21-809 of the Transportation Article of the Annotated Code of Maryland and have identified additional locations as potential speed camera installation sites pending there designation as school zone sites ("Additional Speed Camera Locations To Be Evaluated") under the Section 21-803.1 of the Transportation Article of the Annotated Code of Maryland. A listing of the proposed and potential sites for speed monitoring systems is available on the County Council's website - http://www.princegeorgescountymd.gov/council

Members of the public are invited to express their views concerning these sites. Persons wishing to testify at the public hearing should register with the Office of the Clerk of the Council at (301) 952-3600, TDD (301) 925-5167. Testimony will be limited to three minutes per speaker. Registered speakers may not relinquish any part of their speaking time to another registered or unregistered individual. Written testimony may be provided to the Clerk of the Council, Room 2198, County Administration Building, 14741 Governor Oden Bowie Drive, Upper Marlboro, Maryland 20772. Free parking and shuttle bus service is available at the Prince George's Equestrian Center parking lots.

Dear Chair Turner:

As required by CB-37-2009/Sec. 26-114.01. Authority to install and utilize speed monitoring systems, Section 3, page 3, which was approved by the County Council on November 3, 2009, I am requesting that the County Council schedule and conduct a public hearing to garner public comment on the attached lists. The list labeled as "Established School Zones" includes locations where staff in the Department of Public Works and Transportation (DPW&T) and the Prince George's County Police Department (PGCPD) have received numerous complaints. Accidents and speed evaluations were used to identify these locations as candidates for designation as school zone sites, which is a requirement of the state law. The list identified as "Additional Speed Camera Locations" includes sites that have been identified as potential installation sites through the DPW&T and PGCPD; however, these sites have not yet been identified as school zone sites. I ask that they also be reviewed so that we may proceed with the installation of speed monitoring systems if they become designated as a school zone site.

In addition, and pursuant to conditions as set forth in CB-37-2009, the Director of the Department of Public Works and Transportation shall establish a citizen advisory committee comprised of two (2) representatives from each Council District and three (3) representatives from the Office of the County Executive for a total of twenty-one (21) members to meet periodically for the purpose of obtaining additional public comment. Consequently, I encourage the Council Members to identify and appoint their representatives prior to the public hearing so that they may be present at the meeting to not only listen to the public comment, but to also be introduced as a representative on the Advisory Committee. It is important to note that the selection of a company to implement Prince George's County's speed monitoring system has been submitted for final review and approval. Considering this, I ask that the Council schedule a public hearing within the next 30 days to allow for the prompt implementation of the Program.
