1. In the matter of the substitution of Corporate Officers application, **t/a Hooter's**, Class B(BLX), Beer, Wine and Liquor, 14707 Baltimore Avenue, Laurel, 20707, **Scott P. Weber**, Chief Legal Officer Hooter's HOA Laurel, LLC, to serve as Authorized Person, in the place instead of **Cal Everett**, Authorized Person. **Mr. Weber** is represented by **Leanne Schrecengost, Esquire. Ms. Schrecengost** confirms with **Mr. Weber** that no changes will happen to the business with the transfer of corporate officers as well as proves **Mr. Weber's** knowledge of the rules and responsibilities of the BOLC including the 6 acceptable forms of ID for liquor sales and the ages to sell/buy alcohol. **Commissioner Camacho** makes a motion to approve the transfer of corporate officers for **t/a Hooter's** in Laurel, MD, seconded by **Commissioner Miles**. After Board voting, the motion carries.
2. In the matter of, **Samranjit "Sunny" S. Gosal**, President/Secretary/Treasurer, for a Class A, Beer, Wine and Liquor for the use of Jattputt, Inc., **t/a Oxon Hill Liquors**, 6369-6371 Livingston Road, Oxon Hill, 20745, transfer from T.Y.C., Corporation, t/a Oxon Hill Liquor, **Kwen Lee Cheung**, President/Vice President/Secretary/Treasurer. Represented by **Robert Kim, Esquire. Mr. Kim** confirms **Mr. Gosal's** knowledge of the rules and responsibilities of the BOLC including the 6 acceptable forms of ID for liquor sales and the ages to sell/buy alcohol. He also states that **Mr. Gosal** will have all employees receive Alcohol Awareness training and has proof of his own Alcohol Awareness training. **Commissioner Forbes** asks **Mr. Gosal** about his application regarding work history at an establishment which sells alcohol, to which, **Mr. Gosal** says he was mainly a cashier.

Commissioner Camacho makes a motion to approve the transfer of Class A liquor licensure, seconded by **Commissioner Miles**. After Board voting, the motion carries.

3. In the matter of, **Cindy Chang**, Owner, **Ryan Wallen**, Owner, for a Class D, Beer and Wine for the use of Cor Restaurant Group, LLC, t/a **Cori's Modern Kitchen & Bar**, 4710 Auth Place, Suite G1, Camp Springs, 20746. Map Presentation from Chief Robert Clark: there are no schools within 1,000 ft of the establishment, no churches within 500 ft of the establishment, and only one business which liquor within a one-mile radius. Both applicants agree to proceed without representation. Hours of operation and seating capacity on the application do not match their current hours. The Board came to agreement that the licensees are to email the Board their current hours of operation and seating for Covid-19 adjustment to store with the application for administrative record. **Commissioner Forbes** confirms with **Mr. Wallen** that no changes will happen to the business without approval as well as proves **Mr. Wallen's** knowledge of the rules and responsibilities of the BOLC including the 6 acceptable forms of ID for liquor sales and the ages to sell/buy alcohol. Commissioner Norman asks Mr. Wallen if he and his staff have gone to Alcohol Awareness training. Mr. Wallen states that he was recertified about 8 months ago, that 10 servers will sell alcohol and undergo group training. **Commissioner Forbes** confirms with **Ms. Chang** that no changes will happen to the business without approval as well as proves **Ms. Chang's** knowledge of the rules and responsibilities of the BOLC including the 6 acceptable forms of ID for liquor sales and the ages to sell/buy alcohol. **Commissioner Forbes** asks **Ms. Chang** to explain the name of the establishment in which she previously worked selling alcohol and what she did there. **Ms. Chang** says that she worked at a restaurant in Tampa, Florida for about two months as a hostess, but she cannot remember the name of the establishment. **Commissioner Camacho** makes a motion to amend the application to reflect that **Ms. Chang** was a hostess at restaurant in Tampa, Florida circa 1998, seconded by **Commissioner Miles**. After Board voting, the amendment to the application was approved. **Commissioner Forbes** has **Mr. Wallen** explain his answer to the same question on the application referring to former employment at an establishment that sells alcohol, in which to amend the application. **Commissioner Camacho** makes a motion to amend the application reflecting **Mr. Wallen** working at Mount Vernon as an executive chef, seconded by **Commissioner Miles**. After Board voting, the motion carries. **Commissioner Camacho** makes a motion to approve the amended application for Class D liquor licensure for t/a **Cori's Modern Kitchen & Bar**, seconded by **Commissioner Miles**. After Board voting, the motion carries.
