**Commissioner Bridgwaters-Simms:** At the Board of License Commissioners, we endeavor to be as efficient as possible in our virtual environment. Thank you for your patience. This is a public meeting subject to the Maryland Open Meetings Act so a truthful, transparent, open, and honest dialogue and record is required. ## PRELIMINARY MATTERS

1. Substitution of Corporate Officers application, **t/a Cambria Hotel at College Park**, Class B(BH), Beer, Wine and Liquor, 8321 Baltimore Avenue, College Park, 20740, Linda Carter to serve as Member instead of Adam Greenberg, Member. Represented by **Linda Carter, Esquire**.

**Ms. Carter** states we're having a corporate restructure at Southern Management, and I agreed to come on this license. I'm currently a licensee on a hotel in Prince George's County.

There are no changes to Ms. Carter's personal information.

**Ms. Carter** is Alcohol Awareness certified.

**Ms. Carter** gave a proffer using the standard questions typically used to qualify the Substitution of Corporate Officers Application. Including what are the six acceptable forms of I.D., and the legal age to purchase and sell alcohol. She was able to answer each question.

**Commissioner Camacho** makes a motion to approve the SCO for t/a Cambria Hotel at College Park, seconded by **Commissioner Norman**.

### NON-EFFECTUATION

**t/a El Toro Liquors** – Review of request to approve an additional one hundred eighty (180) days to effectuate the license. Represented by **Robert Kim, Esquire**.

**Mr. Kim** states he submitted a package last night to include work order documents, inspection documents, obtaining a U&O, MD lottery process, and photographs of the interior and exterior of the property. We're down to two inspections the final inspection and building inspection. The sprinkler system needed a new water line, WSSC had to find another entry way for the sprinkler system. My clients hired third party inspectors, due to the county not being able to accommodate them in a timely manner. Once we get the fire inspection completed, the county will issue the U&O.

**Mr. Harjinder** states we think everything can be completed by the end of September.

**Mr. Kim** respectfully asked the Board for time to complete the remaining inspections.

**State Delegate Del Deni Taveras** commends Mr. Harjinder for informing and meeting with the community in discussing the layout, opening date, and hours of operation. Mr. Harjinder gives donations to the community.

**Commissioner Camacho** makes a motion to grant 120 days to effectuate the license, seconded by **Commissioner Norman**.

King Kong Restaurant and Lim's Liquors are in opposition of this application and are represented by **Linda Carter, Esquire**.

There are several Civic associations in opposition of this application and are not represented by an attorney.

Applicant does not have an attorney, acknowledge her right to an attorney and agree to move forward without an attorney.

**Chief Clark** gave a maps presentation.

**El Rancherito** has been in operation since December 2022.

**Commissioner Bridgwaters-Simms** asked the standard questions used to qualify this type of license. Including what are the six acceptable forms of I.D., and the legal age to purchase and sell alcohol. **The applicant couldn't confidently answer the qualifying questions.**

**The Board recommended that the applicant seek legal counsel and this case will be continued to the next available hearing.**

**Commissioner Camacho** makes a motion to extend the application until Ms. Rosales comes with an attorney, seconded by **Commissioner Norman**.

**After Board vote, the motion carries.**

2. Porfirio Martinez, CEO, Juan Batres, Member/Authorized Person, for a Class B, Beer and Wine for the use of Texas Parrillada, LLC, **t/a Texas Parrillada**, 7400 Livingston Road, Oxon Hill, 20745.

Applicant does not have an attorney, acknowledge his right to an attorney and agree to move forward without an attorney.

**Chief Clark** gave a maps presentation.

**Commissioner Bridgwaters-Simms** asked the standard questions used to qualify this type of license. Including what are the six acceptable forms of I.D., and the legal age to purchase and sell alcohol. The applicants were able to answer each question.

**The original application doesn't reflect the full restaurant's square footage, the kitchen was excluded.**

**Commissioner Camacho** makes a motion to continue this matter until a U&O is provided, seconded by **Commissioner Norman**.
